Statement of intent

At Millthorpe, we are committed to treating all students with equity and to seeking equal opportunities for all. We have high expectations of all young people at Millthorpe and we use our Pupil Premium funding to raise the attainment of financially disadvantaged students of all abilities. We strive to close the attainment gap between Pupil Premium students and their peers and we endeavour to narrow social, economic and cultural gaps that may have a negative impact on students' learning so that all students can enjoy a more rewarding experience of school life and can achieve their potential.

Our Pupil Premium strategy is underpinned by the Education Endowment Foundation's research into best use of Pupil Premium funding and we follow the tiered approach to Pupil Premium spending set out in the EEF Guide to the Pupil Premium. This means we spend approximately 50% on teaching (for example, professional development, recruitment and retention and support for early career teachers); 25% on targeted academic support (for example, intervention to address underperformance, small group tuition and one-to-one support) and 25% on wider strategies (for example, behaviour support, breakfast and after-school clubs and increasing attendance). This year, the additional recovery funding means we are able to increase the amount spent on targeted academic support.
